

# Terms and Conditions – Job-posting.ai

Last Updated: June 22<sup>nd</sup>, 2023

'Terms and Conditions' (the "**Terms**") is the document governing the contractual relationship between the provider of a service and its user. On the web, this document is often also called 'Terms of Service' (ToS), 'Terms of Use', EULA ('End-User License Agreement'), 'General Conditions' or 'Legal Notes'

Please read these Terms and our [Privacy Policy](#) ("**Privacy Policy**") carefully because they govern your use of the Job-posting.ai, trade name of Matching.works Technologies B.V. ("**Job-posting.ai**") website located at [www.job-posting.ai](http://www.job-posting.ai) (the "**Site**"), Job-posting.ai's copy content generation services, and any copy content generated by Job-posting.ai's services for you based on your User Content (defined below) ("**Generated Content**"). To make these Terms easier to read, the Site, our services, and the Generated Content are collectively called the "**Services**."

## 1 - Agreement to Terms

By using our Services, you agree to be bound by these Terms. If you do not agree to be bound by these Terms, do not use the Services. If you are accessing and using the Services on behalf of a company (for example your employer) or other legal entity, you represent and warrant that you have the authority to bind that entity to these Terms. In that case, "you" and "your" will refer to that entity.

The Services are intended for users who are at least 18 years old. Person under the age of 18 are not permitted to use or register for the Services.

For certain features of the Services you will need an account. It is important that you provide us with accurate, complete and current account information and keep this information up to date. If you don't, we might have to suspend or terminate your account. To protect your account, keep the account details and password confidential, and notify us right away of any unauthorized use. You are responsible for all activities that occur under your account.

If we do, we'll let you know by posting the updated Terms on the Site and/or may also send other communications (for example by email). It's important that you review the Terms when we update them or you use the Services. If you continue to use the Services after we have posted updated Terms it means that you accept and agree to the changes. If you don't agree to be bound by the changes, you may not use the Services anymore. Because our Services are evolving over time we may change or discontinue all or any part of the Services, at any time and without notice, at our sole discretion.

## 4 - Feedback

We appreciate user feedback, comments, (product) ideas, proposals and (product) suggestions for improvements to the Services ("**Feedback**"). If you choose to submit Feedback, you agree that we are free to use it without any restriction or compensation to you.

## 5 - Subscriptions

Job-posting.ai requires payment of a fee for use of the Services (or certain portions thereof) and you agree to pay such fees.

**(a) General**

When you purchase a subscription for the Services (“**Subscription**”), you expressly authorize us and/or our third-party payment processor to charge you for that Subscription. We may ask you to supply additional information relevant to your Subscription, including your credit card number, the expiration date of your credit card and your email and postal addresses for billing and notification (such information, “**Payment Information**”). You represent and warrant that you have the legal right to use all payment method(s) represented by any such Payment Information. When you initiate a Subscription, you authorize us to provide your Payment Information to third parties so we can complete the transaction related to your Subscription and to charge your payment method for the type of Subscription you have selected (plus any applicable taxes and other charges). You may need to provide additional information to verify your identity before completing your Subscription (such information is included within the definition of Payment Information). By initiating a Subscription, you agree to the pricing (currency), payment and billing policies applicable to such fees and charges, as posted or otherwise communicated to you. All payments for Subscriptions are non-refundable and non-transferable except as expressly provided in these Terms. All fees and applicable taxes, if any, are in general payable in Euros (for customers from European countries) and United States dollars. (for customers from other countries than European countries).

**(b) Subscriptions**

If you purchase a Subscription, you will be charged the annual Subscription fee, plus any applicable taxes, and other charges (“**Subscription Fee**”), at the beginning of your Subscription and each year thereafter, at the then-current Subscription Fee. BY PURCHASING A SUBSCRIPTION, YOU AUTHORIZE JOB-POSTING.AI TO INITIATE RECURRING NON-REFUNDABLE PAYMENTS AS SET FORTH BELOW. If you purchase a Subscription, we (or our third-party payment processor) will automatically charge you each year on the anniversary of the commencement of your Subscription, using the Payment Information you have provided until you cancel your Subscription. No less than thirty (30) days and no more than sixty (60) days before your Subscription term ends, or otherwise in accordance with applicable law, Job-posting.ai will send you a reminder with the then-current Subscription Fee. By agreeing to these Terms and electing to purchase a Subscription, you acknowledge that your Subscription has recurring payment features and you accept responsibility for all recurring payment obligations prior to cancellation of your Subscription by you or Job-posting.ai. Your Subscription continues until cancelled by you or we terminate your access to or use of the Services or Subscription in accordance with these Terms.

**(c) Cancelling your Subscription**

You may cancel your Subscription for a full refund within fourteen (14) calendar days of your initial purchase. AFTER THAT, YOUR PURCHASE IS FINAL AND YOU WILL NOT BE ABLE TO CANCEL THE PURCHASE AND/OR RECEIVE A REFUND OF YOUR SUBSCRIPTION FEE AT ANY TIME. But if something unexpected happens in the course of completing a transaction, we reserve the right to cancel your transaction for any reason; if we cancel your transaction we will refund any payment you have already remitted to us for such transaction. Without limiting the foregoing, you may cancel your Subscription at any time, but please note that such cancellation will be effective at the end of the then-current Subscription period. EXCEPT AS SET FORTH ABOVE WITH RESPECT TO YOUR INITIAL SUBSCRIPTION PURCHASE, YOU WILL NOT RECEIVE A REFUND OF ANY PORTION OF THE SUBSCRIPTION FEE PAID FOR THE THEN CURRENT SUBSCRIPTION PERIOD AT THE TIME OF CANCELLATION. To cancel, you can send an email to [termination@job-posting.ai](mailto:termination@job-posting.ai). You will be responsible for all Subscription Fees (plus any applicable taxes and other charges) incurred for the then-current Subscription period. If you cancel, your right to use the Services will continue until the end of your then current Subscription period and will then terminate without further charges.

**(d) Free Trials**

We may offer to certain qualifying users paid Subscriptions on a free trial basis (“**Free Trial**”) for a specified period of time. If we offer you a Free Trial, the specific terms of your Free Trial will be provided at signup. Your use of the Free Trial is subject to your compliance with such specific terms. Certain limitations may exist with respect to combining Free Trials with any other offers. ## **6 - Your Content**

### **(a) *Posting Content***

### **(c) *Your Responsibility for User Content***

Subject to your compliance with these Terms, Job-posting.ai hereby grants you a non-exclusive, worldwide, license, with the right to sublicense, to use, copy, modify, sell, create derivative works based upon, distribute, publicly display, and publicly perform Generated Content for your lawful business purposes.

### **(f) *Intellectual Property Ownership***

We may make available through the Services content that is subject to intellectual property rights, including Generated Content. We and our licensors (as applicable) retain all rights to that content.

## 8 - Usage Requirements, Prohibited Actions, and Job-posting.ai's Enforcement Rights

**(a) You agree that you will use the Services:**

1. Only in a lawful manner and in compliance with all applicable laws;
2. In accordance with the Terms, the license granted in Section 7(e), and any documentation, usage guidelines, parameters, and other requirements provided to you by Job-posting.ai or its licensors, as may be modified by Job-posting.ai or its licensors from time to time;
3. In a manner that does not violate these Terms, any agreement between you and anyone else or our or a third party's rights;
4. In a manner that does not infringe, misappropriate, or otherwise violate any of Job-posting.ai's or its licensors' rights or those of any other person or entity;
5. As it relates to Generated Content, in a manner that is consistent with the OpenAI mission and Charter, which is incorporated herein by reference, as determined by OpenAI in its sole discretion; and
6. In compliance with, and you will not attempt to circumvent, any call rate limits or other restrictions that may be established by Job-posting.ai or its licensors from time to time.

You also agree that you will make (reasonable) efforts to reduce the likelihood, severity, and scale of any societal harm caused by your use of the Services (including the use and sharing of Generated Content) by following the OpenAI API Usage Guidelines.

**(b) You agree not to do any of the following prohibited actions:**

1. Sell, lend, lease, distribute, transfer or grant any rights in or to any or all of the Services, (except for Generated Content as permitted under this Agreement);
2. 3. Attempt to access or search the Services or download content from the Services using any engine, software, tool, agent, device or mechanism (including spiders, robots, crawlers, data mining tools) other than the software and/or search agents provided by Job-posting.ai;
4. Decompile, reverse compile, decipher, disassemble, reverse assemble, translate, or reverse engineer any component or software used to provide the Services, discover the source code of any component of the Services, or attempt to do any of the foregoing;

23. Use the Services in a way that causes societal harm including, but not limited to, (i) misleading end users that any Generated Content was human-generated for generative use cases that do not involve a human in the loop, (ii) generating spam, and (iii) generating content for dissemination in electoral campaigns;
24. Use the Services in a way that violates any applicable law or regulation including, but not limited to, (i) illegal activities such as child pornography, gambling, piracy, violating copyright, trademark or other intellectual property laws, (ii) accessing or authorizing anyone to access the Services from an embargoed country as prohibited by the United States government, and (iii) threatening, stalking, defaming, defrauding, degrading, victimizing, or intimidating anyone for any reason; and
25. Encourage or enable any other individual to do any of the foregoing.

Job-posting.ai is not obligated to monitor access to or use of the Services or to review or edit any content. However, we have the right to do so for the purpose of operating the Services, to ensure compliance with these Terms and to comply with applicable law or other legal requirements. We reserve the right, but are not obligated, to remove or disable access to any content, including User Content, at any time and without notice, including, but not limited to, if we, at our sole discretion, consider it objectionable or in violation of these Terms. We have the right to investigate violations of these Terms or conduct that affects the Services. We may also consult and cooperate with law enforcement authorities to prosecute users who violate the law.

## **10 - Termination**

Upon any termination, discontinuation or cancellation of the Services or your account, the following Sections will survive: 5 (a), 5 (b), 5 (c) (only for payments due and owing to Job-posting.ai prior to the termination), 5 (d), 6 (b), 6 (c), 7 (e), 7 (f), 7, 8, 10, 11, 12, 13, 14, 15 and 16.

### **11 - Indemnification**

You agree to defend, indemnify, and hold Job-posting.ai harmless, including their subsidiaries, affiliates, and all of their representative officers, agents, partners, and employees, from and against any loss, damage, liability, claim, or demand, including reasonable attorneys' fees and expenses, made by any third party due to or arising out of: (i) your Generated Content, (ii) use of the Site, (iii) breach of these Terms, (iv) any breach of your representations and warranties set forth in these Terms; (v) your violation of the rights of a third party, including but not limited to intellectual property rights; (vi) any overt harmful act toward any other user of the Site with whom you connected via the Site. Notwithstanding the foregoing, we reserve the right, at your expense, to assume the exclusive defense and control of any matter for which you are required to indemnify us, and you agree to cooperate, at your expense, with our defense of such claims. We will use reasonable efforts to notify you of any such claim, action, or proceeding which is subject to this indemnification upon becoming aware of.

### **12 - Warranty disclaimers**

THE SERVICES ARE PROVIDED WITHOUT WARRANTY OF ANY KIND, "AS IS," WITHOUT LIMITING THE FOREGOING, WE AND OUR LICENSORS EXPLICITLY DISCLAIM ANY IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, QUIET ENJOYMENT AND NON-INFRINGEMENT, AND ANY WARRANTIES ARISING OUT OF COURSE OF DEALING OR USAGE OF TRADE. We and our licensors make no warranty that the Services will meet your requirements or be available on an uninterrupted, secure, or error-free basis. We make no warranty regarding the quality, timeliness, accuracy, completeness, truthfulness, or reliability of any information or content on the Services.

### **13 - Limitation of Liability**

**(a)** TO THE MAXIMUM EXTENT PERMITTED BY LAW, NEITHER JOB-POSTING.AI NOR ITS SERVICE PROVIDERS AND LICENSORS INVOLVED IN CREATING, PRODUCING, OR DELIVERING THE SERVICES WILL BE LIABLE FOR ANY INCIDENTAL, EXEMPLARY, SPECIAL OR CONSEQUENTIAL DAMAGES, OR DAMAGES FOR LOST REVENUES, LOST PROFITS, LOST BUSINESS OPPORTUNITY, LOST SAVINGS, LOSS OF DATA OR GOODWILL, SERVICE INTERRUPTION, COMPUTER DAMAGE OR SYSTEM FAILURE OR THE COST OF SUBSTITUTE SERVICES OF ANY KIND ARISING OUT OF OR IN CONNECTION WITH THESE TERMS OR FROM THE USE OF OR INABILITY TO USE THE SERVICES, WHETHER BASED ON WARRANTY, CONTRACT, TORT (INCLUDING NEGLIGENCE), PRODUCT LIABILITY OR ANY OTHER LEGAL THEORY, AND WHETHER OR NOT JOB-POSTING.AI OR ITS LICENSORS OR ITS SERVICE PROVIDERS HAVE BEEN INFORMED OF THE POSSIBILITY OF SUCH DAMAGE, EVEN IF A LIMITED REMEDY SET FORTH HEREIN IS FOUND TO HAVE FAILED OF ITS ESSENTIAL PURPOSE.

#### **14 - Governing law and forum choice**

These Terms and any action related thereto will be governed by the Dutch law, without regard to its conflict of laws provisions. Except as otherwise expressly set forth in Section 15 “Dispute Resolution”, the exclusive jurisdiction for all Disputes (defined below) that you and Job-posting.ai are not required to arbitrate will be the court located in Utrecht (The Netherlands), and you and Job-posting.ai each waive any objection to jurisdiction and venue in such courts.

#### **15 - Dispute Resolution**

##### **(a) *Informal Negotiations***

To expedite resolution and control the cost of any dispute, controversy, or claim related to these Terms (each “**Dispute**” and collectively, the “**Disputes**”) brought by either you or us (individually, a “**Party**” and collectively, the “**Parties**”), agree first attempt to negotiate any Dispute (except those Disputes expressly provided below) informally for at least thirty (30) days before initiating arbitration. Such informal negotiations commence upon written notice from Party to the other Party.

##### **(b) *Binding Arbitration***

Any dispute arising from the relationships between the Parties to this contract shall be determined by one arbitrator who will be chosen in accordance with the Arbitration and Internal Rules of the European Court of Arbitration being part of the European Centre of Arbitration having its seat in Strassbourg, and which are in force at the time application for arbitration is filed, and of which adoption of this clause constitutes acceptance. The seat of arbitration shall be Utrecht, The Netherlands. The language of the proceedings shall be Dutch. Applicable rules of substantive law shall be the law of The Netherlands.

##### **(c) *Restrictions***

The Parties agree that any arbitration shall be limited to the Dispute between Parties individually. To the full extent permitted by law, (i) no arbitration shall be joined with any other proceeding; (ii) there is no right or authority for any Dispute to be arbitrated on a class-action basis or to utilize class action procedures; (iii) there is no right or authority for any Dispute to be brought in a purported representative capacity on behalf of the general public or any other persons or companies.

##### **(d) *Exceptions to Informal Negotiations and Arbitration***

The Parties agree that the following Disputes are not subject to the above provisions concerning informal negotiation and binding arbitration: (i) any Disputes seeking to enforce or protect, or concerning the validity of, any of the intellectual property rights of a Party; (ii) any Dispute related to, or arising from, allegations of theft, piracy, invasion of privacy, or unauthorized use; and (iii) any claim for injunctive relief. If this provision is found to be illegal or unenforceable, then neither Party will elect to arbitrate any Dispute falling within that portion of the provision found to be illegal or unenforceable and such Dispute shall be decided by a court of competent jurisdiction listed for jurisdiction above, and the Parties agree to submit to the personal jurisdiction of that court.

#### **16 - General Terms**

##### **(a) *Reservation of Rights***

Job-posting.ai and its licensors exclusively own all right, title and interest in and to the Services, including all associated intellectual property rights. Notwithstanding the foregoing, Job-posting.ai’s licensor, OpenAI LLC, exclusively owns all right, title and interest in and to Generated Content. Job-posting.ai claims no ownership of Generated Content. You acknowledge that the Services are protected by copyright, trademark, and other laws of the United States and foreign countries. You agree not to remove, alter or obscure any copyright, trademark, service mark or other proprietary rights notices incorporated in or accompanying the Services.

**(b) Entire Agreement**

These Terms constitute the entire and exclusive understanding and agreement between Job-posting.ai and you regarding the Services, and these Terms supersede and replace all prior oral or written understandings or agreements between Job-posting.ai and you regarding the Services. If any provision of these Terms is held invalid or unenforceable by an arbitrator or a court of competent jurisdiction, that provision will be enforced to the maximum extent permissible and the other provisions of these Terms will remain in full force and effect. You may not assign or transfer these Terms, by operation of law or otherwise, without Job-posting.ai's prior written consent. Any attempt by you to assign or transfer these Terms, without such consent, will be null. Job-posting.ai may freely assign or transfer these Terms without restriction. Subject to the foregoing, these Terms will bind and inure to the benefit of the parties, their successors and permitted assigns.

**(c) Notices**

Any notices or other communications provided by Job-posting.ai under these Terms will be given: (i) via email; or (ii) by posting to the Services. For notices made by email, the date of receipt will be deemed the date on which such notice is transmitted.

**(d) Waiver of Rights**

Job-posting.ai's failure to enforce any right or provision of these Terms will not be considered a waiver of such right or provision. The waiver of any such right or provision will be effective only if in writing and signed by a duly authorized representative of Job-posting.ai.
